Background & Discussion:

Pursuant to section 12 and 13 of the Joint Powers Agreement for the Formation of the Bear Valley Basin Groundwater Sustainability Agency, and pursuant to Article 7.3 of the Bylaws of Bear Valley Basin Groundwater Sustainability Agency, the Board is to adopt an annual budget by “resolution or otherwise.”

On June 16, 2020, the Board reviewed and discussed proposed Budget for the Fiscal Year ending June 30, 2020. No changes were requested by the Board. The budget is balanced and reflects member agency contributions for administrative costs, for preparation of the Groundwater Sustainability Plan (GSP), and in support of Replenish Big Bear (the Project).

Administrative costs include estimated bank fees, legal and audit fees, purchasing Quickbooks software, and professional fees for preparation of the GSP. Costs for the GSP are fully funded through a grant from the Department of Water Resources (DWR). The City of Big Bear Lake, Department of Water and Power (DWP) is advancing BVBGSA for costs associated with the GSP and will recover those advances from the DWR grant.

Financial Impact:

The proposed Budget is balanced and remains within the funding authorized by the member agencies.

1. General Fund appropriated resources in the amount of \$1,040,598 shall be appropriated for use in full and transferred to the following funds:
2. Operations and Maintenance Fund appropriated resources from General Fund of in the amount of \$192,658, and appropriated uses in the amount of \$192,658;
3. Replenish Big Bear Fund appropriated resources from General Fund of in the amount of \$847,940, and appropriated uses in the amount of \$847,940;

In Fiscal Year 2019/20, the Bear Valley Basin Groundwater Sustainability Agency (BVBGSA) will pursue two main objectives:

1. Continue to support the efforts of the Replenish Big Bear Project
2. Working toward completion of the Bear Valley Basin Groundwater Sustainability Plan

Replenish Big Bear

Replenish Big Bear is a forward-looking water supply project that protects our community's water supplies well into the future. Upon completion it will supplement the Valley's essential water supplies with hundreds of millions of gallons of clean water each year.

The clean water produced through Replenish Big Bear will be used to enhance water levels throughout the Valley, supporting the area's unique and diverse fish and wildlife. Replenished water levels support the community's recreation and tourism industry and protect the community's drinking water supplies, keeping Big Bear a great place to visit and live.

The member agencies (Big Bear Area Regional Wastewater Management Agency - BBARWA, Big Bear Municipal Water District - BBMWD, Big Bear City Community Services District - BBCCSD, and the City of Big Bear Lake Department of Water and Power - BBLDWP) will continue to move the project through regulatory review and work toward obtaining funding so that the project will be both beneficial to and affordable for the community.

In Fiscal Year 2018/19 each member agency pledged \$250,000 in funding for preliminary design and environmental services. In Fiscal Year 2019/20 an additional \$250,000 was pledged by each member agency.

Bear Valley Basin Groundwater Sustainability Plan

The Bear Valley Basin Groundwater Sustainability Plan (the Plan) is a planning document that may facilitate obtaining future funding for Replenish Big Bear and complies with the Sustainable Groundwater Management Act (SGMA). The Plan is fully funded through a \$177,000 grant from the California Department of Water Resources under Proposition 1. BBLDWP will advance funding for the Plan and be reimbursed with Prop 1 grant proceeds as those are received.

Pursuant to section 12 and 13 of the Joint Powers Agreement for the Formation of the Bear Valley Basin Groundwater Sustainability Agency (BVBGSA), and pursuant to Article 7.3 of the Bylaws of Bear Valley Basin Groundwater Sustainability Agency, the Board is to adopt an annual budget by “resolution or otherwise.”

On June 16, 2020, the Board reviewed and discussed proposed Budget for the Fiscal Year ending June 30, 2021. No changes were requested by the Board. The budget is balanced and reflects member agency contributions for administrative costs. The proposed budget reflects the Board’s adoption Addendum No.1 to the Amended and Restated Memorandum of Understanding on June 16, 2020. Accordingly, cost associated with Replenish Big Bear will be billed directly to the member agencies, eliminating the BVBGSA clearinghouse process.

Administrative costs include estimated costs for office supplies, bank fees, legal and audit fees. Costs related to the Ground Water Sustainability Plan will be carried from fiscal year 2019/20.

The Budget is balanced and remains within the funding authorized by the member agencies.

Replenish Big Bear

Replenish Big Bear (the Project) is a forward-looking water supply project that protects our community's water supplies well into the future. Upon completion it will supplement the Valley's essential water supplies with hundreds of millions of gallons of clean water each year.

The clean water produced through Replenish Big Bear will be used to enhance water levels throughout the Valley, supporting the area's unique and diverse fish and wildlife. Replenished water levels support the community's recreation and tourism industry and protect the community's drinking water supplies, keeping Big Bear a great place to visit and live.

The member agencies (Big Bear Area Regional Wastewater Management Agency - BBARWA, Big Bear Municipal Water District - BBMWD, Big Bear City Community Services District - BBCCSD, and the City of Big Bear Lake Department of Water and Power - BBLDWP) will continue to move the project through regulatory review and work toward obtaining funding so that the project will be both beneficial to and affordable for the community. In Fiscal Year 2019/20 BBARWA was awarded a grant for \$500,000 for Replenish Big Bear. A second BBARWA grant application for over \$4.5 million has been approved by the Department of Water Resources. BBARWA is finalizing the paperwork for this grant. This grant funding is expected to support regulatory review, design, piloting and potentially cover some construction costs as the Project moves forward.

In Fiscal Year 2018/19 each member agency pledged \$250,000 in funding for preliminary design and environmental services. In Fiscal Year 2019/20 an additional \$250,000 was pledged by each member agency. As Fiscal Year 2019/20 draws to a close, funding from these pledges remains available to continue support for Replenish Big Bear and will be carried forward to, or otherwise reauthorized by the member agencies for use in Fiscal Year 2020/21. The above \$500,000 grant will provide \$125,000 reimbursement to each of the four member agencies.

Bear Valley Basin Groundwater Sustainability Plan

The Bear Valley Basin Groundwater Sustainability Plan (the Plan) is planning document that may facilitate obtaining future funding for Replenish Big Bear and complies with the Sustainable Groundwater Management Act (SGMA). The Plan is fully funded through a \$177,000 grant from the California Department of Water Resources under Proposition 1. BBLDWP will advance funding for the Plan and be reimbursed with Prop 1 grant proceeds as those are received. The Plan is expected to be completed by the end of calendar year 2020. Funding was appropriated for the Plan in Fiscal Year 2019/20. Residual funding and encumbrances from Fiscal Year 2019/20 will be carried forward from Fiscal Year 2019/20 to Fiscal Year 2020/21.

3.6 Status of the Groundwater Sustainability Plan (GSP)

3.7 Management and Board Members Discussion

Chair Ludecke inquired into the construction cost as well as, the operations and maintenance (O&M) cost for Replenish Big Bear Project (Project). Administrator, Reggie Lamson, responded that the BVBGSA was awarded \$4.5M from the Department of Water Resources (DWR) Prop 1 Grant for planning, piloting, and a portion of the construction costs for the Project. WSC has calculated that the Agencies will be eligible for reimbursement for \$1.27M of cost and will only be responsible for approximately \$730K. Additionally, there is a grant application pending with the USBR, that will increase the reimbursement approximately \$45K. The final commitment from each agency for this phase of the work will probably be approximately \$200K each.

Chair Ludecke asked “when will the next shoe drop”. Reggie responded that the Agency has hired Dr. Anderson, a leader in lake water quality modeling, to answer the DWR’s questions. MWD General Manager, Mike Stephenson, added that the issue is whether the proposed treated wastewater discharge will cause degradation of the lake water quality and what level of reverse-osmosis (RO) will be required.

Reggie shared that the Department of Drinking Water (DDW) has concerns about wells within 100 feet of the lake at full capacity. The Agency hired an attorney to look at the DDW regulations and has sent a letter to the DDW regarding what the appropriate regulation method that should be applied to this project. We are waiting a response. David added that the member agencies see value in the Project. Most likely there will be some RO required. The balance is maximizing lake quality while minimizing cost to the community. Mike added that

Valley District is willing to pay \$176 per acre foot of water released from the dam. The Project may enable us to release up to 300-acre feet from the dam which would enable us to decrease the O&M cost to the community.

No additional business came before the Board. At 5:04 p.m., Chair Ludecke adjourned the meeting.

**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE

WHEREAS, on October 18, 2017, the Bear Valley Basin Groundwater Sustainability Agency (“Agency”) adopted the Bylaws of the Bear Valley Basin Groundwater Sustainability Agency (“Bylaws”).

WHEREAS, Section 53910 of the Government Code allows agencies to draft resolutions authorizing practices with regard to the form, issuance, delivery, endorsement and payments of warrants, provided agencies conform substantially to practices specified in Sections 53911, 53912, 53913, or 53915 and such practices are convenient, efficient and in the public interest.

WHEREAS, pursuant to Article 11 of the Bylaws, the Board of Directors of the Agency (“Board of Directors”) are authorized to amend the Bylaws by resolution.

WHEREAS, all members of the Board received written notice of the proposed amendment, in accordance with the requirements listed in Article 11 of the Bylaws.

WHEREAS, the Board of Directors desires to amend the Bylaws in order to establish a new practice for the issuance of checks for the payment of Agency claims.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Bear Valley Basin Groundwater Sustainability Agency does hereby amend its Bylaws as follows:

1. Article 7, Section 2 of the Bylaws shall be amended to read as follows (new language is underlined, removed language is struck):

~~APPROVAL OF WARRANTS AND SIGNATURE OF CHECKS.~~ The Board adopts the following process: when funds are available for the payment of claims delineated in the Agency budget (“Claims”), the approval of the Claims shall, without the issuance of any warrant, be under the authority of the Treasurer and Administrator to pay the Claims by check or electronic transfer. Registers and transfers shall contain substantially the same information as required by law to be maintained for a warrant. At the subsequent Board meeting, the Board shall review and approve all disbursed Claim payments. ~~shall approve all warrants and authenticate issuance of checks in payment thereof.~~ A check register showing the check number, payee, amount, and the purpose of each check will be sent to the Board Members no later than 72 hours before each regular Board meeting. ~~Checks in payment of utility bills, postage, payroll, payroll taxes, credit union collections, petty cash, emergency repairs and invoices subject to discount and interfund transfers may be disbursed prior to Board approval. Such items shall be set forth on the next regular check register and presented to the Board dependent on timing of actual check delivery.~~

2. This Resolution shall become effective upon adoption by the Board of Directors.
